Trend: The population of the Tallahassee MSA (Gadsden, Jefferson, Leon and Wakulla Counties) was estimated at 404,606 in 2025, up 5.3% from 2020. The Tallahassee MSA's annual rate of growth in the 2020s has been around 1.0%, compared with 0.5% in the 2010s and 1.4% during the decade of the 2000s.
